

Rules for Super Saturday raffle

1. This raffle is conducted every second (2nd) Saturday of the month in the Liquid Lounge. Tickets are on sale from 3pm and the draw commences approximately 5pm.
2. Entry is gained by the purchase of raffle tickets from the compere
3. Tickets may be purchased by members and guests of Diggers The Entrance.
4. Free tickets issued via:
 - MEMBERS ONLY: TAB Punters Challenge Entry = \$5 free tickets (25 numbers). Issued between 10am and no later than 4.50pm
 - MEMBERS ONLY: Purchase any item from the Classics Menu in Outside In between 12pm – 4.50pm & get \$5 free tickets (25 numbers). Limit of one free ticket per member, per day)
 - Purchase \$10 worth of tickets - get \$2 worth of tickets free (60 numbers total)
 - Purchase \$20 worth of tickets - get \$5 worth of tickets free (125 numbers total)
 - Purchase \$30 worth of tickets - get \$10 worth of tickets free (200 numbers total + Jackpot Joker Entry Ticket)
5. Jackpot Joker entries available for Financial Members of Diggers The Entrance only.
6. Minimum age of participants is 18 years.
7. The following persons are ineligible to participate in the raffle:
 - a. Staff of Diggers The Entrance and their partners
 - b. Directors of Diggers The Entrance and their partners
 - c. Staff employed by any contractor and their partners
 - d. Any persons participating in the conduct of the raffle
8. \$1 equates to 5 numbers
9. The minimum purchase is \$5 (inclusive of GST) for 25 raffle numbers for all raffles conducted by Diggers The Entrance.
10. Ticket prices:

\$5	25 Numbers
\$10	50 Numbers
\$20	100 Numbers
\$30	150 numbers
11. Prize winners are determined by BSG Raffle Plus MFP Program. One prize will be awarded per winning raffle number.
12. The compere determines the order in which all prizes are distributed.
13. Prize winners are announced via the Liquid Lounge PA and CCTV systems. After the initial announcement of prize winner the compere will repeat the announcement a further 3 times at 4 minute intervals. Should the prize winner not be present, the prize will be considered not claimed.
14. Prize winners must present winning raffle ticket to the compere. After verification, the prize is issued.
15. Unclaimed prizes will become the next available prize.
16. Draws will continue until all prizes have been claimed on each draw night.
17. The Club may cancel, pause, change, delay, or end the promotion or any draw if unexpected issues happen, such as technical problems, power failures, viruses, fraud, or anything else outside the Club's control that affects the fairness or operation of the promotion.
18. Decisions about the promotion may be made by the Club's CEO or someone the CEO appoints, including judges or scrutineers for draws. These decisions are final, do not require consultation, and the Club will not discuss or correspond about them.
19. Members should complete their transactions early to avoid missing out due to long queues & delays.
20. The Club is not responsible for delays that prevent members from entering the promotion, attending a draw, or being present when winners are selected, and it does not have to delay the draw because of those issues.
21. The Club is not responsible if members cannot hear PA announcements because of where they are in the venue or because of sound quality issues.
22. A prize will not be awarded if the Club reasonably believes it resulted from a machine fault or technical problem.
23. The Club is not liable for incorrect information caused by equipment failures, programming errors, technical issues, or mistakes by third parties connected to the promotion.
24. If the Club decides a person is not eligible or entitled to a prize, the prize will not be awarded.
25. The Duty Managers decision is final in the case of disputes on each draw night.
26. These terms and conditions may be amended, suspended or terminated by the Club, in its absolute discretion, at any time without notice. Participants are precluded from making any claim against the Club for any compensation in respect of any damage or loss in respect of any amendment, suspension or termination.
